The meeting was called to order at 7:00 pm in the Board Room at Village Centre. The Pledge of Allegiance was recited and Mayor Whorrall welcomed those present. Mayor Whorrall recognized the unfortunate passing of "Mac" Malcolm Heffernan – lifelong resident of the Village of Manlius, a volunteer firefighter for many years; Assistant Fire Chief; Commander of the American Legion; was instrumental in making sure the Memorial Day parade and 4th of July parades went smoothly – and wanted the minutes to reflect his service to the Village of Manlius.

PUBLIC HEARING – 315 E. Seneca Street Special Use Permit

Motion by Trustee McGrew, seconded by Trustee Abdo-Rott to open the public hearing. Motion Carried 6-0

There being no one present wishing to speak it was on Motion by Trustee Pilewski, seconded by Trustee McGrew to close the public hearing. Motion Carried 6-0.

SEQR – 315 E. Seneca Street

Motion by Trustee McGrew, seconded by Trustee Noble to declare Lead Agency for the purposes of SEQR for this Type II action. Motion Carried 6-0.

APPROVE SPECIAL USE PERMIT – 315 E. Seneca Street

Motion by Trustee McGrew, seconded by Trustee Abdo-Rott to approve the application for Special Use to allow for a mixed use (residential on upper floors) on the property located at 315 E. Seneca Street. Motion Carried 6-0.

PETITION – Manlius Chamber of Commerce; Healthy Lifestyles Fair

Judy Dardzinski, representing the Manlius Chamber of Commerce, was present along with Laurie Flanagan to request permission to hold the Healthy Lifestyles Fair in the Village Centre (entire building) on October 3rd and 4th.

PRESENTATION – Warner Energy

Terry Brown and Zach Drescher, representatives of Warner Energy, gave a presentation on the installation of solar panels on the Village Centre which would save a guaranteed 5-6 thousand dollars a year for 20 years. They feel that this is a conservative amount however there are several factors that contribute to the savings and this is the amount that can be guaranteed. Mr. Brown and Mr. Drescher distributed handouts and answered the questions posed by the Board. This is a way for entities to "go green" and still realize a savings.

30-Day Notice Requirement Waiver – Ember Beer Co – 604 East Seneca Street C. Motion by Trustee McGrew, seconded by Trustee Abdo-Rott to waive the 30-day notice requirement for a liquor license for 604 East Seneca Street, Ember Beer Co. Motion Carried 6-0.

TRUSTEE REPORTS

<u>Trustee Hopkinson</u> – Historical Society is having a Wine/Antiques and appraisal event on February 28, 2014 from 6:30 to 9:00 p.m. Attended the Library Board annual meeting and gave information from that meeting to the Clerk. Noted that the Manlius Library was ranked 31st out of 1400 libraries.

<u>Trustee Pfeiffer</u> – Nothing to report.

Trustee Noble- Has been working with Mrs. Sawmiller on the Recreation Dept budget.

Trustee Pilewski – Will be attending a Finance Committee meeting on Friday at 9:00 a.m. to begin discussing the budget. <u>Trustee McGrew</u> – Attended Police Committee meeting – results of the inspection for national certification and scored 100%. The CRC meeting will be held on Thursday at Village Centre at 6:00 p.m.

Trustee Abdo-Rott – met with Patty and Jim to discuss the Gazebo and look at Rec Room renovations next to the Rec office. Talked about the project to refinish the gym floor. Will be meeting with Patty and Jim on Friday to review the budget.

ATTORNEY REPORT

The Option Agreement for the MacDougal property discussed for purchase is the same as the Board approved in the past and this new agreement will run from March 1 – August 31st with an amount payable to the property owner of \$1000 per month. The current Option has expired.

Motion by Trustee Pilewski, seconded by Trustee McGrew to authorize the Mayor to execute the Option Agreement Extension as set forth above. Motion Carried 6-0.

MAYOR REPORT

Last Thursday the Clerk and Mayor attended the Senior Centre Strategic Planning meeting.

Mayor Whorrall opened the floor to Chief Buskey who arrived after the start of the meeting.

Chief Buskey advised the Board that per the policy put in place by the Board and failure to comply with that policy, he recommends removal of Todd Wilbur from the civil service roster.

Removal – Part-time Firefighter Wilbur

Motion by Trustee McGrew, seconded by Trustee Abdo-Rott to authorize the removal of Todd Wilbur as a part-time firefighter/paramedic for the Manlius Fire Department. Motion Carried 6-0.

Appointment – Full-time Firefighter/Paramedic Wright

Chief Buskey asked the Board to consider authorizing the hiring of Caroline Wright to the vacant full-time firefighter/paramedic position. This would be a promotion from part-time to full-time status.

Motion by Trustee McGrew, seconded by Trustee Pfeiffer to authorize the appointment of Caroline Wright to the vacant firefighter/paramedic full-time position in the Manlius Fire Department effective immediately. Motion Carried 6-0.

PUBLIC FORUM

Ray Dill of East Seneca Street advised the Board that he used his snow blower to clear access to fire hydrants in the area of his property and that he received a complaint from a resident who was upset by it.

ADJOURN

There being no further business before the Board it was on Motion by Trustee Abdo-Rott and seconded by Trustee Noble to adjourn the meeting. Motion Carried 6-0.
