PUBLIC HEARING (6:05pm)

Special Use Permit for Seneca Savings Bank

Motion by Trustee Pilewski, second by Trustee Chapman to open the Public Hearing for theSpecial Use Permit application for Seneca Savings Bank.MOTION CARRIED 4-0

Geoff Hillenbrand from Plumbline Engineering, who is representing Seneca Savings Bank Proposal at 325 Fayette St. reviewed information presented from the previous meeting on 3/12/24. Addressing comments from the county.

- All water and sanitary items will be addressed with OCWA and WEP.
- Explore shared access with Taco bell, the Village property, and the site itself.
- Ingress and separate egress requested by the County, but DOT only wants the ingress. The county feels there could be more green space in the front of the building if this was implemented. The board would like it to explore more at the county's request and if the DOT would approve.

Mayor Whorrall asked if there were any comments from the public. No Comments. Motion by Trustee Chapman, second by Trustee Abdo-Rott to close the Public Hearing for the Special Use Permit application for Seneca Savings Bank. No vote currently until we here on the recommendation from the DOT. Will vote at the next meeting on May 14, 2024.

CDBG Grant

The Mayor explained that we are applying for a grant with the County to be able to install new playground equipment at Mill Run Park and at the Village Centre. Equipment would also be handicap assessable.

Trustee Chapman spoke more about the grant. We had applied last year for the \$150,000 grant and it was denied because of so many applicants. This year they are only offering the \$50,000 that we are applying for. The playgrounds are used frequently, and we feel that this would be a good start to replace some of the old equipment at Mill Run Park. Part of the process of applying was to hold a public hearing.

Motion by Trustee Chapman, seconded by Trustee Pilewski to set a Public Hearing at the next board Meeting on May 14, 2024, at 6:05am for the Restore NY Grant. MOTION CARRIED 4-0 Mayor Whorrall explained since we did not receive the NY Forward Grant we are moving forward and applying for the Restore NY Grant. The grant is for 2 million, and it is to restore buildings on East Seneca St. The property addresses are 111 E. Seneca St., 209-217 E. Seneca St. and 301-309 E. Seneca St.

Municipal Resolution Supporting 2024 Restore NY Round 8 Application

WHEREAS, the Village of Manlius is eligible for grant funding under Round 8 of the Restore NY Communities Initiative Municipal Grant Program, and

WHEREAS, the Village Board has considered proposals that qualify for funding under the program and selected a project to be included in an application that will be submitted to Empire State Development Corporation (ESDC) as follows: Redevelopment of 111, 209-217, and 301-309 E Seneca Street. The project will involve the demolition, reconstruction, and/or rehabilitation of three vacant, blighted properties on East Seneca Street, creating a total of 21 residential units and 6 commercial spaces; and

WHEREAS, the Village recognizes that the East Seneca Street project is a priority project that will contribute to the renewal of this downtown area, strengthen the local economy, and increase the quality of life for residents; and

WHEREAS, the Village has worked with the property owners/developers to ensure that this project is aligned with local development plans and is seeking ways to find funding avenues to complete this project with public and private funds; and

WHEREAS, this project is consistent with all existing local plans, the proposed financing is appropriate for the project, the project will facilitate effective and efficient use of existing and future public resources so as to promote both economic development and preservation of community resources, and the project develops and enhances infrastructure and/or other facilities in a manner that will attract, create and sustain employment opportunities in Manlius; and NOW THEREFORE BE IT RESOLVED that the Village Board hereby supports and will sponsor an application for Restore NY funding for 111, 209-217, and 301-309 E Seneca Street and will administer the grant in accordance with all applicable rules and regulations established by ESDC; and

BE IT FURTHER RESOLVED that the Village of Manlius supports this Restore NY application submission and the \$500 application fee that is required for the East Seneca Street project; and BE IT FURTHER RESOLVED that the Mayor is authorized to sign the applications and any agreements required by ESDC for grant funding that results from the application. Taco Bell Special Use Permit Proposal

Matt Napierala from Napierala Consulting representing Mike McKracken from Hospitality Restaurant Group reviewed the referral from the County.

- The County would like us to make sure NYSDOT reviews the TIS report. This has been submitted and hopefully will have a response by tomorrow for the Planning Board Meeting. It is an interesting request since NYSDOT does not have jurisdiction on Stickley Dr.
- There is a concern about the parcel owned by the village and to keep that open as a back way out for both Seneca Savings Bank and Taco Bell. Napierala states that is still an open discussion and can be changed but does not feel that it would work. The controlled exit would be better than adding a back exit.
- Encouraged to resolve encroachment service and encourages a swap of land. Napierala was not clear on where the right of way to Stickley Dr. that the village owns. It is only 60 ft right of way. We do not show it in our survey.
- Shared parking- There is the Village lot and the recreation building lot that are maintained for recreational events. Even though Taco Bell has a fence, they are not going to throw people out if parking there for a recreational event.

Motion by Trustee Chapman, seconded by Trustee Pilewski to approve the Special Permit as submitted for Taco Bell. MOTION CARRIED 4-0

RESOLUTION OF THE VILLAGE BOARD OF TRUSTEES OF THE VILLAGE OF MANLIUS: April 9, 2024

The Applicant, Restaurant Hospitality Group, has applied for a special use permit for a drivethrough at the proposed Taco-Bell Cantina at 2-4 Stickley Drive, tax map parcel # 023.-01-12.1.

At its December 12, 2023 meeting, the Village Board of Trustees approved a resolution and local law changing the zoning of this parcel from Municipal to Commercial-1.

Under the Village of Manlius Zoning Code, section 99-14, a restaurant in a Commercial-1 zone may have a drive-through with a special use permit.

At its March 5, 2024 meeting, the Village of Manlius Planning Board issued a positive recommendation to the Village Board on the special use permit application.

The Village Board held a public hearing on this matter at its March 12, 2024 meeting.

At its March 27, 2024 meeting, the Onondaga County Planning Board issued a resolution proposing one modification to the project – that the applicant complete a traffic impact study, submit that study to the New York State DOT, and complete any mitigation required by DOT. The applicant has completed a traffic impact study and submitted it to DOT.

At its meeting of April 9, 2024, the Village Board resolved as follows:

- 1. Pursuant to the New York State Environmental Quality Review Act and its implementing regulations (SEQRA), the Village Board will act as lead agency for an uncoordinated review of this matter. This is a type 2 action under SEQRA section 617.5 because it involves the reuse of a commercial structure, and it is therefore exempt from SEQRA review. In addition, based on the environmental assessment form and all relevant information, the Village Board determines that this zone change will have no significant adverse environmental impact, and that all questions in part 2 of the EAF may be answered "No, or small impact."
- 2. The Village Board of Trustees has reviewed the standards applicable to special use permit applications under Village of Manlius Code section 99-27(B) and (H). Based on this review, the Village Board of Trustees **GRANTS/DENIES** the application for a special use permit for a drive-through.
- 3. The applicant must obtain site plan approval from the Planning Board.
- 4. The applicant must comply with any mitigation measures required by the State Department of Transportation, as a condition of this special use permit approval and as a condition of site plan approval.

Northern Credi Union Special Permit

Brody Smith, the Engineer, spoke on the changes that had been requested.

- Elimination of parking spots from 49 to 29 spots.
- Changed the driveway to orient towards Elmbrook Dr. instead of straight out. This is also the safer option versus exiting the CVS parking lot.
- Evergreens are present for screening of the lights. Also, a photometric study was done on the ITMs which will not result in light escaping the property.
- Agreed to install signage indicating that the driveway is one-way and right turn only.

Mayor Whorrall presented the petition that was received by the neighborhood. They had concerns on directional signage, no left turns, and for the traffic laws of the village to be enforced. We will

ask the Town of Manlius Police to keep an eye on the area. Mayor Whorrall feels most of the concerns have already been addressed.

Abdo Rott asked about more sidewalks on Fayette St. Smith stated that there is an existing sidewalk now and that they will be putting one on Eureka Dr.

Trustee Chapman feels that his concerns have sufficiently been addressed.

Trustee Oley asked about the possibility of connecting all the parking lots, so that if someone is in that area, they could get to all the businesses (Starbucks, Wellnow, Northern Credit Union, CVS) without having to go back onto Fayette St. Smith stated that something could be implemented down the road once the opportunity arose. This would have to be a conversation with the two owners.

Rachel Weiter, 123 Eureka Dr. asked about the number of ATM's and if 2 are needed. Northern Credit Union originally had 3 and cut it down to 2. The drawing makes it look bigger. She also commented that she appreciates the sidewalks being installed, but because the traffic is so low in the area, they never felt the need for sidewalks. That is why they are worried about the traffic.

Mayor Whorrall asked for a vote. Motion by Trustee Oley, seconded by Trustee Pilewski to approve the Special Use Permit as submitted for the Northern Credit Union MOTION CARRIED 3-1

RESOLUTION OF THE VILLAGE BOARD OF TRUSTEES OF THE VILLAGE OF MANLIUS: April 9, 2024

The Applicant, Northern Credit Union, has applied for a special use permit for a drive-through at the proposed credit union at 314 Fayette Street.

Under the Village of Manlius Zoning Code, section 99-15, a bank in a Commercial zone may have a drive-through with a special use permit.

The Village Board held a public hearing on this matter at its February 13, 2024 meeting.

At its March 27, 2024 meeting, the Onondaga County Planning Board issued a resolution proposing two modifications to the project -1) that the applicant coordinate with the New York State DOT regarding access, traffic data, and the SWPPP; and 2) that the applicant submit a lighting plan to the Village. The applicant has complied with these two proposed modifications.

At its meeting of April 9, 2024, the Village Board resolved as follows:

- 1. Pursuant to the New York State Environmental Quality Review Act and its implementing regulations (SEQRA), the Village Board will act as lead agency for an uncoordinated review of this unlisted action. Based on the environmental assessment form and all relevant information, the Village Board determines that this zone change will have no significant adverse environmental impact, and that all questions in part 2 of the EAF may be answered "No, or small impact."
- 2. The Village Board of Trustees has reviewed the standards applicable to special use permit applications under Village of Manlius Code section 99-27(B) and (H). Based on this review, the Village Board of Trustees **GRANTS/DENIES** the application for a special use permit for a drive-through.
- 3. The applicant must obtain site plan approval from the Planning Board.
- 4. The applicant must comply with any mitigation measures required by the State Department of Transportation, as a condition of this special use permit approval and as a condition of site plan approval.
